PARTICIPATION FEES

- The Brainerd Public School District requires participants in athletic programs to pay a participation fee in order to be included in the program. This fee helps to fund the program, but does not cover all of the cost of engagement. The district uses general fund revenues to support the athletic programs.
- - o <u>priscovery woods</u> agrees to collect registration information to determine participants prior to the start of each season according to a schedule provided by the Forestview Middle School Activity office.
 - o The athletic fees are due and payable, as with Forestview Middle School students, prior to actual participation in the program.
 - administration agrees to assist, if needed, in the collection of fees and physicals for students who are registered to participate.
- Discovery woods students would not be eligible for athletic scholarships through Brainerd Public Schools.

PROGRAM CONSIDERATIONS

- Schools will cooperate with FMS Administration and Coaches to support and enforce Brainerd Public Schools policies, procedures, and rules.
 - o The provision includes verification, by appropriate officials, that participating students are in good standing academically.
 - o The provision includes verification, by appropriate officials, that participating students are in regular attendance.
 - o The provision includes notification of the FMS Activities Director of any participating students who may fall out of good standing or regular attendance during the course of the activity season.
- The Brainerd Public School District may not increase or adjust the number of coaches solely on the basis of increased participation from students enrolled outside the district.

 Discovery Woods

 student participation may have the effect of pushing the participation level beyond district standards for advisors/coaches. This, however, may not require an automatic increase in additional coaching assignments. The district reserves the right to determine the number of coaching assignments based solely on the number of participants from the public middle school regardless of the number of students from another school.
- Communication with the student's school through the coaches and athletic department would be used to determine discipline and academic concerns.
- Transportation plans will follow FMS needs and drop off points.
